Earthquake Engineering Research Institute - New England Chapter Mission

The Earthquake Engineering Research Institute - New England Chapter is dedicated to providing members with the technical knowledge, leadership and advocacy skills, collaborative networks, and multidisciplinary context to achieve earthquake resilience in New England and worldwide. The chapter is committed to reducing the earthquake risk in New England and worldwide, by advancing the science and practice of earthquake engineering, by improving understanding of the impact of earthquakes on the physical, social, economic, political and cultural environment and by advocating comprehensive and realistic measures for reducing the harmful effects of earthquakes.

Chapter Bylaws

Article I. Name and Operation

- 1. The name of the organization shall be the Earthquake Engineering Research Institute New England Chapter, hereafter called the NE Chapter.
- 2. The operations of the NE Chapter shall be consistent with the provisions set forth in the Bylaws of the Earthquake Engineering Research Institute, hereafter called the Institute.

Article II. Area and Membership

- 1. The area of the NE Chapter shall include the New England states of Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont.
- 2. Categories of membership, specifying voting privileges and eligibility for elected and appointed offices, shall be established by the Board of Directors of the NE Chapter with the approval of the Institute. (Attachment 1 shows the current Membership Categories.)

Article III. Officers and Directors

- 1. The Officers of the NE Chapter shall be a President, a Secretary/Treasurer, a President-Elect and an Ex officio (non-voting) Past President. The Officers and three Directors at-large shall constitute a Board of Directors in which the government of the NE Chapter shall be vested.
- 2. The Officers and Directors shall be elected by Members eligible to vote.
- 3. The President-Elect shall serve a term of two years. Following this, they shall serve a two-year term as President and a two-year term as Past-President.
- 4. The elected Secretary/Treasurer shall serve a term of two years. The Secretary/Treasurer is eligible to serve additional two-year terms.
- 5. Each elected Director at-large shall serve a term of two years. Directors at-large are eligible to serve additional two-year terms.
- 6. All terms start at the opening of the Board of Directors meeting immediately following the election and continue until successors are elected and assume offices.
- 7. Terms of office shall be staggered in order to assure continuity within the Board of Directors. An Officer Succession Plan that shows the terms of all Officers and Directors shall be maintained by

- the Secretary, and shall be approved annually at the Board of Directors meeting immediately following the election.
- 8. The President-Elect shall automatically become President in the event of a vacancy in the office of President. Time served as President in this event will not affect the length or start date of the two year term as President to which the President-Elect would otherwise succeed. When there is no President-Elect, an Acting President shall be chosen by the Board of Directors from among the currently elected Board members for the duration of the presidential term. The position vacated by the selected Board member shall be filled in accordance with these Bylaws.
- 9. In the event of a vacancy in the office of Secretary/Treasurer, an Acting Secretary/Treasurer shall be chosen by the Board of Directors from among the Directors at-large for the duration of the term. The Director at-large position vacated shall be filled in accordance with these Bylaws.
- 10. In the event of a vacancy before the end of term of a Director at-large, the vacancy shall be filled for the duration of the term by an appointment made by the Board of Directors. An Acting Director will serve as a voting member of the Board of Directors. An Acting Director remains eligible to serve additional two-year terms as an elected Director.
- 11. Ex officio (non-voting) Directors may be appointed by the Board of Directors to head specific activities for specified terms not to exceed two years unless reappointed by the Board of Directors.
- 12. The Board of Directors shall oversee the preparation of an Annual Report that shall be submitted to the Institute.
- 13. At meetings of the Board of Directors, a majority of the Officers and voting Directors shall constitute a quorum.

Article IV. Nomination and Election of Officers

- The Nominating Committee shall consist of not less than two individuals. These are
 recommended to be from eligible membership categories, but are not required to be members
 of the Chapter or the Institute. (Attachment 1 shows the current Membership Categories.)
 Officers and voting Directors are not eligible to serve on the Nominating Committee. Members
 of the Nominating Committee are not eligible for nomination for elected positions.
- 2. The Nominating Committee shall choose one or more candidates for election to each office and obtain the consent of each nominee to serve if elected. Nominees will be solicited from the general membership as part of this process.
- 3. The Secretary shall send a ballot, containing the list of official nominees and a space for a write-in vote for another candidate for each office, to each eligible voter at least 20 days previous to the day in October established as the deadline for receiving ballots.
- 4. Ballots returned to the Secretary up to the time of counting shall be opened and counted by two tellers appointed by the President. For each office the candidate receiving the highest number of votes cast shall be declared elected.

Article V. Board of Directors' Meetings

- 1. The Board of Directors shall hold at least four meetings per year.
- 2. Notice of call for a Board of Directors meeting shall be given to Board members not less than fourteen days in advance of the meeting date.
- 3. All meetings of the NE Chapter Board of Directors shall be governed by Robert's Rules of Order, Newly Revised, except as provided by these Bylaws.
- 4. Either the President or a quorum of the Board of Directors can call special meetings.

Article VI. Committees

- 1. The Board of Directors shall appoint the Nominating Committee.
- 2. The President shall appoint other committees deemed necessary by the Board of Directors.

Article VII. Bylaw Amendments

- 1. Bylaws may be adopted or amended only by the following procedures:
 - 1. Any Member may propose an amendment to the Bylaws.
 - 2. The Board of Directors shall approve the proposal for balloting, revising it as needed for consistency with related Bylaws.
 - 3. The Secretary/Treasurer shall send a ballot showing the approved proposal to each eligible voter at least 20 days previous to the day established as the deadline for receiving ballots.
 - 4. To become effective the Bylaws or amendments thereto shall receive an affirmative vote of not less than a majority of the responding voters.
- 2. Operations of the NE Chapter not specifically addressed by the current Bylaws shall be at the discretion of the Board of Directors.

Article VIII. Dues, Finances, and Assets

- Activities of the NE Chapter shall be financed by annual Chapter dues collected by the Institute, expense allocations from and as approved by the Institute, net proceeds from Chapter-sponsored activities, and grants received by the Chapter.
- 2. The Board of Directors shall determine the amount of the dues at a meeting prior to October of each year.
- 3. The NE Chapter shall establish bank accounts, or participate in Institute accounts, as necessary for conducting business.
- 4. The NE Chapter's fiscal year shall be from January 1 to December 31, or as established by the Institute.
- 5. The property of the NE Chapter is irrevocably dedicated to charitable and educational purposes meeting the requirements for exemption provided by Internal Revenue Service 501(c)(3) organizations and no part of the net income or assets of this organization shall inure to the benefit of any private persons.
- 6. Upon dissolution of the NE Chapter, after paying or adequately providing for all of its debts and obligations, the remaining assets, if any, are irrevocably dedicated to the Institute.

Attachment 1: Membership Categories

The following are membership categories for the NE Chapter:

Regular Members of the NE Chapter are Regular, Young Professional and Honorary individual members of the Institute, and representative members from EERI Subscribing Members, who have also paid NE Chapter dues.

Local Members are individuals who are not members of the Institute but have paid NE Chapter dues.

Student Members are Student members of the Institute or other students who have expressed interest in Chapter activities who have paid NE Chapter dues.

Retired Members are Retired Members of the Institute, residing in New England, who have expressed interest in Chapter activities and have paid NE Chapter dues.
